H LINE (NIGHTS) UNEMPLOYMENT INSTRUCTIONS (TWO WEEKS)

PLEASE CALL YOUR PROCESSING CENTER OR USE THE LIVE CHAT OPTION TO REOPEN YOUR CLAIM. The processing center number is located on the top of past correspondences you've received from the ODJFS. Business hours are 8:00 AM – 5:00 PM Monday – Friday, except holidays. You have to call or chat with them to reopen your claim because you were laid off a few weeks ago and all of those weeks haven't cleared yet, meaning the correct effective date won't be offered online OR on the 877#. Whether you go online or call the 877# to reopen your application for benefits, the correct date you need

<u>will not be available</u>. Another option is using the "live chat" line on the front page of the ODJFS unemployment home page in the bottom right corner. If you get on early, you are usually assisted in just a few minutes.

Please tell the processing center this as soon as you get them on the phone or in live chat:

The date offered by ODJFS as the effective date for me to reopen my claim is incorrect. My **last day of work was 5/16/25 so my effective date is 5/18/25.** DO NOT use the date ODJFS is offering because it will create a break in claim and I won't get paid. **Don't answer the union questions** because we're not a hiring hall. **Don't answer NO to the job search.** If asked for job search click YES, then enter Ohio Assembly Plant, 650 Miller Road, Avon Lake, OH 44012 and type the mass layoff number after Ohio Assembly Plant. in both job spaces

Reopen your application for unemployment benefits using **Mass Layoff #** <u>2500309</u>. Your last day worked is <u>05/16/2025</u> and your return-to-work date is <u>06/02/2025</u>. <u>PLEASE NOTE</u>: You will need to call your <u>processing center or use the live chat option</u> to reopen your claim on Monday, 5/19/25 and then visit the ODJFS web site <u>two times</u> afterward to file for unemployment benefits, see below:

- 1. MON., MAY 19, 2025 Call your processing center or use the live chat option to reopen claim.
- 2. SUN., MAY 25, 2025 Claim layoff week ending MAY 24, 2025.
- 3. SUN., JUNE 1, 2025 Claim layoff week ending MAY 31, 2025. **PLEASE NOTE: OHAP will pay you for Memorial Day, so you need to claim the holiday pay as earnings when you claim this week. Example: \$25.335 (hourly rate) x 8 (hours) = \$202.68 (what you need to claim as earnings).

FOR ASSISTANCE WITH CLAIMS ISSUES (pay held, denied, break in claim) please call the processing center and schedule a return call or you can use the chat line in the bottom right corner of the main page once you log to get assistance with claim issues and even with reopening your claim when the correct date isn't available online or on the 877#. Keep typing "chat with live agent" and hitting send and eventually the computer will ask for your name and how you need them to assist you. You'll be put on a hold and then the live person will let you know they're there, and hopefully will be able to assist you soon.
