**UPCOMING HOLIDAYS – holiday break, Martin Luther King Jr. Day:** Please see your Unit Committeeperson or Steward at your location if you are unsure about what holidays you have off or the eligibility requirements for holiday pay.

**UNION OFFICES CLOSED DURING HOLIDAYS:** UAW Local 2000 and all UAW International and regional offices will close on Tuesday, December 23<sup>rd</sup> and reopen on Monday, January 5<sup>th</sup>. The Benefits office and Human Resources at OHAP will also be closed throughout the entire Christmas holiday period.

**MEMBERS WHO WOULD HAVE BEEN LAID OFF FOR THE WEEKS OF 12/22/25 AND 12/29/25:** You will be paid short work week for the first week and holiday pay for the entire second week. **Please don't file unemployment for those weeks.**

### **H LINE LAYOFF (TWO WEEKS)**

Reopen your application using Mass Layoff # **2500723**. Your effective date will be **1/04/26**. Your last day worked is **1/02/26** and your return to work date (for unemployment purposes) is **1/19/26**. See below for dates you need to file:

1. **MONDAY, 1/05/26** – Call your processing center/ use the live chat option to reopen.
2. **SUNDAY, 1/11/26** – Claim layoff week ending 1/10/26.
3. **SUNDAY, 1/18/26** – Claim layoff week ending 1/17/26.

**IMPORTANT:** If you run out of unemployment money for the year, you still need to file weekly claims and turn in the denial paperwork to HR each week in order to get full SUB pay for those weeks.
