UPCOMING LAYOFF: Due to the Martin Luther King, Jr. holiday, you will be paid **SHORT WORK WEEK for the FIRST WEEK**. Please follow instructions below to claim your 2nd week. Call your processing center or use the live chat option to reopen your application.

Reopen your application using **Mass Layoff # 2500724**. Your effective date will be 01/25/2026. Your last day worked (for unemployment purposes) is 01/23/2026 and your return to work date is 02/02/2026. See below for filing dates:

Monday, 01/26/2026 – Call your processing center or use live chat option to reopen your application.

Sunday, 02/01/2026 – Claim layoff week ending 01/31/2026.

NEXT PAID HOLIDAY: Martin Luther King Jr. Day, Monday, January 19th: Please see your Unit Committeeperson or Steward at your location if you are unsure about eligibility requirements for holiday pay.

If you are nominated, you must fill out either an acceptance or denial form ***before leaving the meeting.*** Forms will also be available at the union hall beginning Monday, February 9th and must be completed and returned to the union hall no later than Friday, February 20th. ****PLEASE NOTE: Do not run for a position on the Election Committee if you are planning to run for an elected position in the upcoming General Election.**

ELECTION COMMITTEE ELECTION: The Election Committee Election will be held at UAW Local 2000 at the March 8th General Membership Meeting. Polls will be open from 1:00 PM to 4:00 PM.

DATE SET FOR GENERAL ELECTION: The General Election will be held Tuesday, May 5, 2026 from 12:00 PM (noon) until Wednesday, May 6, 2026 at 12:00 PM (noon) (24 hours). The Run-Off Election (if necessary) will be held on Tuesday, May 12, 2026 from 12:00 PM (noon) until Wednesday, May 13, 2023 at 12:00 PM (noon) (24 hours). Further details will be communicated in upcoming bulletins or postings.
