H LINE LAYOFF (TWO WEEKS)

Reopen your application with Mass Layoff # **2600096**. Your effective date is **03/15/2026**. Your last day worked is **3/13/2026** and your return to work date is **03/30/2026**. See below for dates you need to file:

1. **NOW** – Call your processing center/ use the live chat option to reopen.
2. **SUNDAY, 03/22/2026** – Claim layoff week ending **03/21/2026**.
3. **SUNDAY, 03/29/2026** – Claim layoff week ending **03/28/2026**.

IMPORTANT: If you run out of unemployment money for the year, you still need to file weekly claims and turn in the denial paperwork to HR **each week** in order to get full SUB pay for those weeks. You can submit your documentation via email to HR at askohap@ford.com or take it to HR.

ONGOING UNEMPLOYMENT ISSUES: If you were laid off the week of February 9th and you're still having issues with unemployment or your OH ID, please keep calling ODJFS until your issue is resolved so it's not an issue next time you are laid off. A lot of the issues with unemployment are happening because people are filing their applications and claims, but not looking in their correspondence inbox and there is an eligibility issue there that ODJFS wants you to respond to. If you file and there's an issue in your inbox that you haven't responded to, they may take your file back and make you file an appeal to get the money owed to you. **PLEASE - ALWAYS CHECK YOUR ODJFS INBOX before and after you file your application and claim.**

GENERAL ELECTION / CONSTITUTIONAL CONVENTION DELEGATE ELECTION: Our membership approved the dates of our upcoming elections at the last meeting. The **General Election** begins on May 5, 2026 at 12:00 PM (noon) and ends May 6, 2026 at 12:00 PM (noon). The **Run-off Election (if necessary) and the election for Constitutional Convention Delegates** begins on May 12, 2026 at 12:00 PM (noon) and ends at 12:00 PM (noon) on May 13, 2026 at **UAW Local 2000 Union Hall**. Resolution forms will be available soon on our page at www.uawlocal2000.org under **UAW NEWS** and at the union hall. The deadline for turning them in is Friday, April 10th, because the membership has to vote on them at General Membership Meeting on April 12th in order to meet the IUAW's deadline.
