

NOTICE OF NOMINATIONS AND ELECTION FOR THE 39TH U.A.W. CONSTITUTIONAL CONVENTION - JUNE 15-18, 2026 IN DETROIT, MICHIGAN

Brothers and Sisters:

On Tuesday, May 12, 2026 and Wednesday, May 13, 2026 the election will be held for delegates to the 39th Constitutional Convention.

The election for Constitutional Convention Delegates will be held at UAW Local 2000 Union Hall, 3151 Abbe Road in Sheffield Village on Tuesday, May 12, 2026 from 12:00 PM (noon) until Wednesday, May 13, 2026 at 12:00 PM (noon) (24 hours). The vote will be conducted to elect three (3) delegates and one (1) alternate delegate from Ohio Assembly Plant to the convention, along with one (1) delegate representing the combined amalgamated units. Each delegate will be elected by simple plurality vote and shall serve a term of four (4) years.

PLEASE NOTE: Members in all 7 units, retirees, regular layoffs, disciplinary layoffs, medical leaves or terminations will vote at UAW Local 2000 Union Hall.

Your nomination acceptance form for the Constitutional Convention Election must be fully completed and clearly printed. Nomination acceptance forms can be hand-delivered to the local union hall or sent via Regular US Mail. If you are hand-delivering your nomination acceptance form to the union hall, it must be hand-delivered between Monday, April 13, 2026 and Friday, April 17, 2026 during regular business hours (8:30 AM to 12:00 PM, then 1:00 PM to 5:00 PM). If you are mailing your nomination acceptance form, it must be addressed to CHAIRPERSON OF THE ELECTION COMMITTEE, C/O U.A.W. LOCAL 2000, 3151 ABBE ROAD, SHEFFIELD VILLAGE, OHIO 44054 and postmarked/receipted between 12:01 AM on Monday, April 13, 2026 and 11:59 PM on Sunday, April 19, 2026. Forms are available at the union hall.

Numbers will be drawn on Wednesday, April 22, 2026 at 4:00 PM at the local union hall, 3151 Abbe Road, Sheffield Village, Ohio. If you are absent, an Election Committee member will draw in your place.

Members in good standing who are not working in the plant for reason of layoff, medical leave, approved leave of absence, disciplinary layoff, vacation or retirement may vote during regular voting hours. **Members must present a driver's license, state ID, plant ID or other photo ID as verification of identification at the polls.**
