The General Election for the above offices will be held on Tuesday, May 5, 2026 from 12:00 PM (noon) until Wednesday, May 6, 2026 at 12:00 PM (noon) (24 hours) at U.A.W. Local 2000 Union Hall, 3151 Abbe Rd. Sheffield Village, OH. A Run-Off Election (**if necessary**) and the election for Constitutional Convention delegates will be held at the same location as the General Election on Tuesday, May 12, 2026 from 12:00 PM (noon) until Wednesday, May 13, 2026 at 12:00 PM (noon) (24 hours). **PLEASE NOTE: All 7 units, retirees, layoffs, disciplinary layoffs, medical leaves or terminations will vote at UAW Local 2000. You must present a driver's license, state ID or other photo ID as verification of identification at the polls.**

Your nomination acceptance form must be fully completed and clearly printed. Nomination acceptance forms can be hand-delivered to the local union hall or sent via Regular US Mail. If you are hand-delivering your nomination acceptance form to the union hall, it must be hand-delivered between Monday, April 13, 2026 and Friday, April 17, 2026 during regular business hours (8:30 AM to 12:00 PM [Noon] and 1:00 PM to 5:00 PM). If you are mailing your nomination acceptance form, it must be addressed to **CHAIRPERSON OF THE ELECTION COMMITTEE, C/O U.A.W. LOCAL 2000, 3151 ABBE ROAD, SHEFFIELD VILLAGE, OHIO 44054** and postmarked/receipted between 12:01 AM on Monday, April 13, 2026 and 11:59 PM on Sunday, April 19, 2026. Nomination forms will also be available at www.uawlocal2000.org and at the union hall.

Numbers will be drawn for positions on the ballot on Wednesday, April 22, 2026 at 4:00 PM at the U.A.W. Local 2000 Union Hall. If you are not present, an Election Committee Member will draw in your place.
