## UPDATES

**Laterals (Labor Pool Jobs):** We’ve heard feedback from the membership requesting that lateral (labor pool) job postings be included in the bulletins so that everything is transparent and visible.

We want to clarify the process and emphasize that **nothing has changed**. Lateral positions are posted within the specific department, and only employees currently working in that department are eligible to bid on them, unless you are on the DTD (Department to Department) transfer list. If you have any questions, please reach out to your Union Representative.

- Lateral move requests are irrevocable, if you request and receive an offer of Lateral Transfer; that will be your assigned operation. You must be in that department to sign up for a lateral.
- If you request and receive an offer of Lateral Transfer; you will be ineligible for six months to take another.
- There is **NO turnaround period for lateral moves**, if you request and receive an offer of Lateral Transfer; that will be your assigned operation.
- All Lateral Transfer requests, for the Undesignated Classification, will be available to any employee, within the **Department and Shift, by seniority**.
- When an opening exists because of an NPJT the last course of action will be soliciting the Extra Labor Pool Employees in Seniority Order.
- If No unassigned Extra Labor Pool Employee desires one of these jobs, then the Lowest Seniority, Extra Labor Pool will be assigned to that job.

If a candidate does not successfully pass, you are not eligible to submit another name – that spot goes to another candidate from the general applicant pool.

Doing so would require rebalancing job classifications.
