OHAP H LINE LAYOFF (TWO WEEKS - 06/22/2026 AND 6/29/26)

Due to the July 3rd holiday falling on the second week of your layoff, you will be paid for the holiday and you'll need to claim that pay when you claim your SECOND week. Please follow the instructions below to claim your weeks:

Reopen your application using the mass layoff number texted to you by HR. Your effective date is **06/21/2026**. Your last day worked is **06/19/2026** and your return to work date is **07/06/2026**. See below for dates you need to file:

- 1. MONDAY, 06/22/2026 – Call your processing center or use the live chat option to reopen.**
- 2. SUNDAY, 06/28/2026 – Claim layoff week ending 06/27/2026.**
- 3. SUNDAY, 07/05/2026 – Claim layoff week ending 07/04/2026. PLEASE CLAIM HOLIDAY PAY WHEN YOU FILE THIS WEEK! Calculate your pay by adding your pay rate + COLA x 8 hours.**

Please note: If you run out of unemployment money for the year and you can't file weekly claims: **EACH WEEK** you will need to print or screenshot the front page of the unemployment screen when you first log in that shows you can't file any more weeks, then take it to HR or screenshot it and email it to HR at askohap@ford.com in order to get your SUB pay. Be sure your name and the date are in the snapshot or printout.
